**Each competitor must have** a valid FIM Baja World Cup or Cross-Country Rallies World Championship licence in accordance with Art. 70.2.1 of the FIM Sporting Code and Art. 09.1 of the FIM Medical Code. A valid driving licence corresponding to the type and capacity of machine used.

Any entry which is not accompanied with the entry fee will be considered as a preliminary one.

#### 3.6 REIMBURSEMENT

The entry fee shall be refunded in full:

- if the event does not take place
- to teams whose entry application is rejected

The organiser may partially refund entry fees, if a competitor cannot take part in the event due to a duly proved case of force majeure. The deduction will be:

- 50% of the entry fee for the requests received until 20 days before the administrative checks.
- 100% of the entry fee for the requests received less than 19 days before the administrative checks.

#### 3.7 ADMISSION OF DRIVERS

The Organizing Committee reserves its right to reject a competitor's entry without explaining their decision. In order to register at any event of the Bajas World Cup, any driver of any nationality being over 18 years old, must hold a FIM competitor license for FIM Cross-Country Rallies World Championship or Bajas World Cup, valid for the year of the event (art.70.2.1 of the FIM Sporting Code and art. 09.1 FIM Medical Code), released by his NMF, and a driving license corresponding to his vehicle's capacity.

A competitor registering at the HunGarian Baja, does it with full awareness of the risks included in this event. The rider releases in advance to the Organizer, his NMF and FIM by any penal or civil responsibility in case of damages or injuries occurred along his participation at HunGarian Baja.

#### 4. INSURANCE

### 4.1. THIRD PARTY LIABILITY INSSURANCE & RIDERS INSURANCE

As per the FIM requirements:

Third Part Liability Insurance:

According to the FIM Sporting Code Art. 110.1.1 and FIM Baja World Cup Regulations (Art. 82.5.1) (see 4.3 below)

• FIM Riders' insurance:

Competitors with a valid FIM Licence are covered for Emergency Medical treatment as per the "Information Notice\_FIM rider'sinsurance programme 23-24" (See Appendix 5 of these Supplementary Regulations) and Art. 82.6 FIM Baja World Cup.

**4.2. ASSISTANCE VEHICLES**, even with Baja ID, may under no circumstances be considered as event participant. Under these conditions, they will not be covered by the event insurance and will circulate under the full responsibility of its owner.

**4.3. TRAFFIC INSURANCE:** Third party risk insurance (Traffic insurance) is compulsory for all crews taking part in the **Baja**. All competitors must have a traffic insurance policy and present it at the administration checking. This insurance is valid both on road sections and special stages.

European citizens please travel with your European Health Insurance card.

#### 4.4 EVENT INSURANCE:

Name of the insurance company: SRC SPECIAL RISK CONSORTIUM GMBH, Kunibertskloster 7-9, D 50668 KÖLN.

The limit of the responsibility is 3.000.000 Eur.

In case of an accident leading to insurance event, the competitor or his representative must make a written statement to the Clerk of the Course, the Competitors Relations Officer, or directly to the Organizer, within 24 hours. This statement must mention the accident circumstances, the names and addresses of the casualties, as well as contact details of the witnesses.

Loss or injury that may be suffered by the drivers themselves or participating vehicles is EXCLUDED. Irrespective of this Third Parties insurance, entrants and drivers are free to take out the policies they deem fit on their own account and at their own discretion. Service vehicles, including those displaying the plates supplied by the Organization, shall under no circumstances be deemed participating vehicles. They are therefore not covered by the Organization's insurance policy and responsibility for them lies solely with their owners. In case of accident, competitors and drivers exempt the event organizers from any liability and waive any right to bring claims against them.

The insurance cover will come into effect from the administrative checking and scrutineering for the Event and end upon the expiry of one of the following time limits, whichever is the later:

- time limit for protests or appeals or the end of any hearing by the Stewards;

- end of the administrative checking and post-event scrutineering;

- end of the prize-giving

#### **5. ADVERTISING / IDENTIFICATION**

#### 5.1 COMPETITORS ARE ALLOWED TO AFFIX ANY KIND OF ADVERTISING ON THEIR VEHICLES, IF:

a) They are authorised by FIM regulations and by the laws of the Country

b) They are not against public decorum.

c) They do not prevent the use of the reserved spaces to the number holder plates and to compulsory advertising of the Organization.

#### 5.2 RESERVED SPACES FOR ORGANIZER ADVERTISING:

The logos will be published in Bulletin

1 - Three race number panels with compulsory advertising 20 x 20 cm on each side and on the front of the vehicle

2 - One baja plate placed vertically at the front of the vehicle

3 - One race number panel with compulsory advertising 30 x 30 cm to the back of the Riders jacket

Compulsory or optional advertising absent or incorrect affixing will entail a penalty of 50% of the entry fees. In case of repeated offence, it will go up to exclusion.

#### 6. TYRES

#### According to Art. 47.05 of FIM Bajas Technical Rules.

Only tyres normally available from commercial or retails sources are authorised.

The tyres shall appear on the tyre manufacturers range catalogue or tyre specification lists available to the general public.

The E approval mark and number as defined by the UN Vehicle Regulation R75 must be present on both the front and rear tyre sidewalls.

The DOT approval mark is also accepted.

The number of tyres is limited to one set (front(s) and rear(s)) per race day. When the day is composed of several stages, the tyres could be marked by the FIM Technical Director and/or his appointed crew (art 47.07 FIM Bajas Technical Rules).

#### 8. ADMINISTRATIVE CHECK

#### 8.2 TIMES/ SCHEDULE:

Thursday 10. August 2023. 08:00-15:00

Individual times for each competitor for the administrative checks will be published on Sportity and <u>www.hungarianbaja.com</u> in a Bulletin.

A time control before the Administrative Checks (C1) will be set up, according to the individualized timetable, as well as after the Administrative Checks.

#### Any delay to the C1 control will be penalized as follows:

- From 1 to 15 minutes: 150€ fine
- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

#### 9. TECHNICAL SCRUTINEERING

9.1 LOCATION: TESCO, 8100 Várpalota, Fehérvári str.17

**9.2 TIME/SCHEDULE:** Thursday 10. August 2023 08:00-16:00

Individual times for each competitor for the technical checks will be published on Sportity and <u>www.hungarianbaja.com</u> in a Bulletin.

There will be a time control before the Scrutineering (C3). The competitors should check-in to this time control according the individual schedule.

#### Any delay to the C3 control will be penalized as follows:

- From 1 to 15 minutes: 150€ fine
- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

#### 9.3 REQUIREMENTS AT TECHNICAL SCRUTINEERING:

- All Vehicles must presented according FIM Bajas Technical Rules 2023
- Vehicles must presented with all start numbers, **baja** plates, and advertisements afixed properly on the designated place.
- Tracking equipment and inter-vehicle signalling system installed and operable even when the ignition removed, it is compulsory to provide 12V
- Scrutineering Sheet- filled up
- Competitor's helmet according art. 01.70 FIM Bajas Technical Rules 2023
- According to art 82.27 of FIM Baja World Cup Regulations: For the entire course, the wearing of an airbag jacket, back and chest protection is compulsory, under pain of disqualification. The airbag system must comply with FIM standards.

The passive protections must be certified as follows:

- Chest: standard EN1621-3
- Back: standard EN1621-2

These protections can be worn separately or combined in a single product.

All Motorcycles/Quads must be according FIM Sound Regulations 2023. For Bajas World Cup 2023 the Maximum Sound Limit is 117,0 dB/A before the race, and during or after the race is 118,0 dB/A.

#### 9.4 INSTALLATION OF THE SAFETY TRACKING SYSTEM AND NAVIGATION SYSTEM

#### 9.4.1 TRACKING AND NAVIGATION SYSTEM (NAV-GPS)

All vehicles must only be fitted with the Safety Tracking System(s) provided by the Organiser. The instructions for the use of the Tracking System is in the Appendix 5 of this Supplementary Regulations. Delivery and installation of the equipment will be carried out right before the administrative checks. Every competitor must return the equipment at the end of the competition, or, if a crew retires- to the STELLA Crew.

#### 9.4.2 CONNECTION OF THE SYSTEMS

It is the competitor's responsibility to ensure that the Safety Tracking System and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the competition.

#### 9.5 PARC FERMÉ

Following the technical scrutineering, each vehicle must be set in Parc Fermé up to 15:00-18:30. Location: Szabadság Tér, 8100 Várpalota.

According to Art 82.25 FIM Baja World Cup Regulations 2023.

- The access to the Parc Fermé is forbidden to everyone except the FIM, FIM Europe and MAMS Jury Members, Technical Stewards, Clerk of the Course, Environmental Stewards, Tracking System

Operators, Parc Fermé Officers, and competitors. Competitors only have access to Parc Fermé to place and remove their vehicles. The operation shall be carried out without delay, and the riders shall leave the Parc Fermé as soon as possible.

- In the parc fermé is compulsory wear an Environmental Mat underneath Motorcycles/Quads/SSV in order to protect the ground from dropping liquids (oil, chain spray, fuel, etc..).
- The minimum dimensions of the Mat must be at least equal to the wheelbase of the motorcycle/Qual/SSV, and the width of the handlebars for motorcycles, or the track wheels width for Quads/SSV.
- This Mat Must be composed of a waterproof sole and an absorbent textile.
- In the Parc Fermé, it is forbidden for a competitor, under penalty of disqualification (or other penalties given as provided for in the FIM Disciplinary and Arbitration Code) from the event: • to refuel; • to make any repairs; • to touch the motorcycle/SSV of any other competitor.
- As an exception to the Parc Fermé status, but subject to the responsibility of an official, a competitor may, in the Parc Fermés for starting, regrouping and end of Stage, change or overhaul, by his own means, a damaged headlight or rear lights. These repairs must be fully completed before the starting time.
- Vehicles will be removed from Parc Fermé only with permission of the Clerk of the Course.

Briefing is compulsory for each competitor, who must confirm his presence by signature.

- At Administrative Checks: Road Book for Shakedown Stage.
- At Briefing: Road Book for Stage1: 19:00
- Entering Park Fermé at the end of Stage1: Road Book for Stage2

The use of the road book provided by the organizer (printed) is mandatory at the event.

#### **11. RUNNING OF THE EVENT**

#### 11.1 PARC FERMÉ BEFORE THE OFFICIAL START

In Start Parc Fermé, crews should be ready 15 minutes before the individual ideal starting time.

#### **11.2 TIME CARD PROVIDING/EXCHANGES**

Time cards will be issued before the Start of each Section, wich must be submitted to the marshalls at the Finish of each Section.

Time card exchanging: at regrouping.

#### 11.3 STARTING PROCEDURE FOR THE SECSIONS will be as follows:

The start of the Section is happening based on an electric clock and lamp, connected to a false start alert system. A digit display will show continuously the time progressing.

The Marshalls will call out loud the 30, 15, 10 seconds then point towards the start equipment. Beginning from the 55 seconds, red lights will be flashed per every second, then at 00 seconds the red lights will go off and below, the green lights will go up. This will be the time to start.

In case the equipment goes wrong, the marshals will change to manual starting procedure.

#### **11.4 CLOSED CONTROL**

Control post must be ready to function 1 hour before the target time for the passage of the first crew. Unless the clerk of the course decides otherwise, they will cease to operate 1 hour after the target time for the last crew, plus the maximum time allowed for the last competitor.

Any crew with a delay higher than 30 minutes at any time control, will have the start refused for the following section, but will not be eliminated from the event.

Penalty to be imposed will be:

30 minutes for the delay in this control, adding the penalty for not taking the Start in the following SS, and adding the maximum time authorized for the selective section not completed.

#### 11.5. EARLY CHECK-IN AT END OF LEG

Early-check in is allowed at TC2C and TC4A

**11.6.** It is strictly forbidden to enter or leave a control area from any direction other than specified by the Road-Book, or to re-enter a control area once checking in has taken place at this control.

#### 11.7. RECONNAISSANCE

Reconnaissance of the route including the Prologue is totally forbidden. Possession of route notes or other informations different from those given by the Organization is forbidden. Penalty decision at Jury's discretion. The only official route is that provided by the Organizer: printed Road-Book.

To help competitors, the Organizer will indicate intersections and features of the route by means of arrows and tapes. The Road-Book shall be the only official document to be followed.

#### **12. FIXED PENALITY**

### TIME CONTROLS – MAXIMUM TIME ALLOWED – PENALTIES

A maximum lateness of 30 minutes for every Road section and a total lateness of 30 minutes in road sections of a Stage is authorised. This lateness will be penalised at a rate of 1 minute per minute or fraction of minute according the Art. 38.8 of General Prescriptions 2023.

### **13. SERVICE PARK**

#### 13.1 LOCATION:

GÁL GYULA SPORS HALL parking lot (with shower and toilet facility in the Sports Hall)

8100. Várpalota, Fehérvári str. 9.

Servicing a competing vehicle will be permitted only at service areas specified by the Organization. Repairs that may be carried out by a team using on-board equipment or equipment carried by another participant in the race are authorized along the whole route. Any other external servicing outside the authorized areas is forbidden and shall be penalized by EXCLUSION at the Jury's discretion.

#### **13.2 ACCESS TIMES FOR SERVICE VEHICLES**

According to Programme.

#### **13.3 OPERATION OF THE SERVICE AREAS**

Entry will be permitted only to Service Vehicles showing the Service Plates. Accompanying team cars can enter only by purchasing a 100€ sticker at the Administrative Checks. Tampering with or falsification of the Service Plates will lead to disqualification of the team to which these service vehicles belong.

The Service Plates will be placed in a visible area of the front windscreen of the vehicle. Each crew will receive **one** Service Plate **free**.

The maximum speed allowed in the service parks is 30 km/h

In the service areas/refuelling is compulsory wear an Environmental Mat underneath Motorcycles/Quads/SSV in order to protect the ground from dropping liquids (oil, chain spray, fuel, etc..).

The minimum dimensions of the Mat must be at least equal to the wheelbase of the motorcycle/Qual/SSV, and the width of the handlebars for motorcycles, or the track wheels width for Quads/SSV.

This Mat Must be composed of a waterproof sole and an absorbent textile.

The engine must be stopped during refuelling.

During the refuelling, each team must have a portable extinguisher (A.B.C. polyvalent powder) of 5 kg minimum, in the proximity of the refuelling post (max. 5 m distance).

Each service team has to ensure that after carrying out their activities on the site, they do not leave any pollutants. They will be checked by the scrutineers, and not complying will entail a 50.000 HUF fine.

Washing and Refuelling is strongly prohibited in the total area of the Service Park!!!

The Organizer calls the attention of the participants, that the Service Park is not guarded at night time!

#### 13.4 REFUELLING

Refuelling is permitted only in commercial fuel stations using fuel on sale to the public. Only the crew may carry out this procedure.

On SS1A, SS1B, SS2A, SS2B, SS3A, SS3B, SS4A, SS4B will be a Neutralization Zone for all Competitors and a separate Remote Refuelling Zone (RRZ) for Motorcycles, Quad, and SSV vehicles only.

The Refuelling station authorised will be indicated in the Road Book with "FUEL STATION".

In here, compulsory to use an Environmental Mat underneath Motorcycles/Quads/SSV.

#### 14. FINAL CHECKS / PROTEST / APPEALS

#### 14.1. FINAL CHECKS

Time and location: see Programme

Any teams required to undergo final checks must immediately follow the instruction of the marshals in charge, even if this prevents them from proceeding to one or more time controls (TC).

#### 14.2. PROTEST

Any complaint shall be presented according to requirements of the Disciplinary and Arbitration Code. They must be submitted by writing to the Clerk of the Course, within the required dates, by the concerned competitors and not by third parties.

# IMPORTANT

For the functional tests and verification, all vehicles must have gone through the installation of the mount, power cord, and antennas.

# **1. POWER CORD**

• Connect the red wire to the positive end of the battery 12V(+), and the grey wire to the negative end (GRD). The power cord must be connected directly to the battery (without interruptions and without contact in the power supply).

• A 3A fuse (not included) should be connected to the red wire.


• Take the cord to the location in which the STELLA III EVO is to be installed. All other wires must be insulated, they cannot touch.



## 2. BASE/MOUNT

• Motorcycles and ATV: The mount can be attached to the handle bar or to a metal plaque close to the navigation system.

• Cars and UTV: The mount can be attached to the panel, or to the roll cage bars. STELLA III EVO buttons must be visible and accessible to the participant (pilot/navigator) even when they are sitting and with the seatbelts buckled.



# IMPORTANT

Leave the cords (antenna and battery) in place with at least 10 cm to spare for easy handling.

At least 5 cm of space behind the mount (bottom right corner) to allow space for power cord/connections.

## **3. GPS ANTENNA**

The GPS antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



## 4. ANTENNA IRIDIUM

The Iridium antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



### **5. RF ANTENNA**

The radio-frequency antenna must be installed vertically to the roll cage bars (cars and UTV) and the forks (motorcycles and ATV). It is mandatory to use separators (included in the kit) to avoid contact with metallic parts and the carbon fibre that surrounds it.

Once the antennas are mounted, take the SMA connection cords to the base/mount where the STELLA III EVO will be installed.

# FIM Riders' insurance information

# The rider's insurance policy set up by the FIM is a service for all the Federations that are part of the programme

for the period from January 1, 2023 to December 31, 2024.

#### Who is covered:

- Riders with a FIM licence issued by a Federation which is part of the FIM riders' insurance programme.
- Riders with a FIM licence issued by ACCR, DMSB, FMS, KNMV, NMF and SMF are not part of the FIM riders' insurance programme and must follow the guidelines of their respective Federation.
- Riders competing in MotoGP, Moto2, Moto3 and MotoE are not part of the FIM riders' insurance programme and must follow the guidelines of their respective Federation.
- Riders competing in a Cross Country Rally must follow the guideline of the Rally organiser.

#### Validity of the insurance:

- · For all events on the FIM Calendar with an International Manifestation Number (IMN).
- For racing activities included in the official programme of the event only!
- Travel to and from the event venue.

#### Scope of coverage:

In case of racing incident, the FIM riders' insurance programme would cover:

 Emergency Medical treatment on the event's place (subsidiary and complementary to any other insurances the rider may hold)

 Repatriation to the rider's country of residence (as declared on the FIM Licence extranet by the rider's FMN)

• Death and Disability (Riders with a FIM licence issued by FFM and FMI have not subscribed this benefit from the FIM riders' insurance programme and must follow the guidelines of their respective Federation for this benefit)

Please note that this is an EMERGENCY insurance and in order to avoid any problems please follow the correct procedure.

#### What to do?

Before departure:

- Always check beforehand whether your personal health insurance card is still valid.
- For European citizens, please travel with your European Health insurance card.
